#### **SECTION 3 - HAZARDS IDENTIFICATION**

#### **Statement of Hazardous Nature**

This product is classified as: Xn, Harmful. Xi, Irritating. F+, Highly Flammable. Hazardous according to the criteria of SWA.

#### **SECTION 4 - FIRST AID MEASURES**

#### **General Information:**

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.

**Inhalation:** If irritation occurs, contact a Poisons Information Centre, or call a doctor. Remove

source of contamination or move victim to fresh air. If breathing is difficult, oxygen may be beneficial if administered by trained personnel, preferably on a doctor's advice. In severe cases, symptoms of pulmonary oedema can be delayed

up to 48 hours after exposure.

**Skin Contact:** Quickly and gently blot away excess liquid. Wash gently and thoroughly with

warm water (use non-abrasive soap if necessary) for 10-20 minutes or until product is removed. Under running water, remove contaminated clothing, shoes and leather goods (e.g. watchbands and belts) and completely decontaminate them before reuse or discard. If irritation persists, repeat flushing and seek

medical attention.

**Eye Contact:** Quickly and gently blot material from eyes. Immediately flush the contaminated

eye(s) with lukewarm, gently flowing water for 15 minutes or until the product is removed, while holding the eyelid(s) open. Take care not to rinse contaminated water into the unaffected eye or onto the face. Obtain medical attention

immediately. Take special care if exposed person is wearing contact lenses. If swallowed, do NOT induce vomiting. Wash mouth with water and contact a

#### **SECTION 5 - FIRE FIGHTING MEASURES**

Ingestion:

Fire and Explosion Hazards: The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. There is a moderate risk of an explosion from this product if commercial quantities are involved in a fire. Firefighters should take care and appropriate precautions. Violent steam generation or eruption may occur upon application of direct water stream on hot liquids. Vapours from this product are heavier than air and may accumulate in sumps, pits and other low-lying spaces, forming potentially explosive mixtures. They may also flash back considerable distances.

Fire decomposition products from this product may be toxic if inhaled. Take appropriate protective measures.

**Extinguishing Media:** In case of fire, use carbon dioxide, dry chemical, foam, water fog. Water fog or fine spray is the preferred medium for large fires. Try to contain spills, minimise spillage entering drains or water courses.

**Fire Fighting:** If a significant quantity of this product is involved in a fire, call the fire brigade. #### **SECTION 6 - ACCIDENTAL RELEASE MEASURES**

Accidental release: This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. For minor spills, clean up, rinsing to sewer and put empty container in garbage. Although no special protective clothing is normally necessary because of occasional minor contact with this product, it is good practice to wear impermeable gloves when handling chemical products. In the event of a major spill, prevent spillage from entering drains or water courses and call emergency services.

#### **SECTION 7 - HANDLING AND STORAGE**

**Handling:** Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Check Section 8 of this SDS for details of personal protective measures, and make sure that those measures are followed. The measures detailed below under "Storage" should be followed during handling in order to minimise

risks to persons using the product in the workplace. Also, avoid contact or contamination of product with incompatible materials listed in Section 10.

**Storage:** Store in a cool (below 30°C), well ventilated area. Protect from direct sunlight. Make sure that surrounding electrical devices and switches are suitable. Check containers and valves periodically for leaks. If you keep more than 25kg of flammable gases, you are probably required to license the premises or notify your Dangerous Goods authority.
